Introduction of Ordinance NO 7-16 Amending Chapter 93, Section 93.02 of Title IX PROHIBITED ANIMALS AND FOWL

ORDINANCE NO. 7-16

AN ORDINANCE AMENDING CHAPTER 93, SECTION 93.02 OF TITLE IX OF THE CODE OF ORDINANCES OF THE VILLAGE OF SOUTH BEND, NEBRASKA; TO PROVIDE FOR THE REPEAL OF CONFLICTING ORDINANCES OR SECTIONS; AND TO PROVIDE FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRPERSON AND THE VILLAGE BOARD OF THE VILLAGE OF SOUTH BEND, NEBRASKA.

Section 1. Section 93.02 of Chapter 93, entitled "PROHIBITED ANIMALS AND FOWL" is amended by deleting it in its entirety and replacing the same with the following: 93.02 PROHIBITED ANIMALS AND FOWL.

(A) It shall be unlawful for any person to keep or maintain within the corporate limits any horse, mule, sheep, cow, goat, swine, or other livestock.

(B) It shall be unlawful for any person to keep or maintain within the corporate limits any poultry, chickens (except as provided in (C) below), turkeys, geese, ducks (except as provided in (C) below), or any other fowl.

(C) The Village Board shall have the authority to approve the keeping of twenty or fewer female chickens and/or ducks within the corporate limits upon application to the Board. Such approval may be withdrawn by the Board at any time should the keeping of said chickens become a nuisance or is in violation of any other Village regulations or laws.

Section 2. That any ordinance or parts of ordinances passed and approved prior to its passage, approval, and publication or posting of this ordinance, and in conflict with its provisions, is hereby repealed.

Section 3. This ordinance shall take effect and be in full force from and after its passage, approval and publication or posting, as required by law.
